## The new brand presents an Outreach opportunity.








## We already know.....

- Unemployment is at 12.6% in California
- Many eligible individuals avoid enrolling in *CalFresh*
- Some low income children and many elders are hungry when nutritious food is an application away
- CDSS offices are at or near capacity
- Once individuals are enrolled they may remain eligible but drop out





## CalFresh is important to better health for millions of Californians.





## Children make up the majority of *CalFresh* participants.

- In FFY09, ~60 percent of California participants were children.
  - ~20 percent preschoolers
  - ~40 percent school-aged children
- Slightly over 70 percent of *CalFresh* households included children in FFY09.





# The *CalFresh* Program is important to California's economy.

• Every \$5 of federal food stamp benefits results in \$9 of new local economic activity.





## Benefits to low-income Californians

- Stretch Food Dollars during this difficult economic period.
- May help children stay healthy and do well in school
- May help reduce obesity
- May help adults stay healthy and able.



#### Important



People currently on Food Stamps do not need to reapply.

 They are automatically enrolled in CalFresh.

They continue receiving benefits on their EBT cards for as long as they qualify.





## In place now!

- California Department of Social Services has begun to:
  - accept online applications
  - waive face-to-face interviews for some applicants
  - operate customer call centers



 expand modified categorical eligibility to focus on income not assets



## In place now!

- California Department of Social Services has begun to:
  - facilitate inter county transfers without interrupted services
  - support the move toward six month reporting
  - automatically enroll children for school meal programs



 Encourage restaurant meals program option for some counties



## **Electronic Benefit Transfer Card**

"Food Stamp Program" used to carry the "welfare" stigma.

Nutrition assistance <u>not</u> provided using stamps since 2001.



## *CalFresh* is a Health and Nutrition Program



 Low-income Californians are at greater risk for obesity, type 2 diabetes and certain types of cancer.

 CalFresh can help ensure access to healthy foods. This may lower the risk for serious health problems.





#### CalFresh English-Language Brochure

#### Calfresh benefits can help you and your family.

- If you are the only person in your household, you can apply for Calfresh.
- If you work full time, you and your family may still qualify for Calfresh.
- You can buy food at any grocery store or farmers' market that accepts EBT cards.
- You never have to pay back Calfresh benefits if you are eligible for them.

#### How much will I receive in Calfresh benefits each month?

- The amount you get depends on your income, expenses, and family size.
- Most households that receive Calfresh benefits get about \$200 each month.

#### How long will it take to get Calfresh benefits?

- If eligible, you will get your benefits within 30 days.
- You may get Calfresh benefits in three days if you earn less than \$150 in the month you apply and if you have less than \$100 in cash. Ask the worker if you can get emergency service when you apply.

#### Special Rules

Immigrants, students, seniors, and former felons should check with the Calfresh office for more information. Rules can change so check with your worker.

#### How much money can I have and still get Calfresh benefits?

You can: • Earn money from a job.

- Get unemployment benefits.
- Get general assistance/relief.
- Get child support.
- · Be part of CalWORKs.
- Get disability benefits.
- · Have money in savings.

Look at the table to see if your income makes you eligible.

If you are a disabled or an elderly person (over 60 years old), tell your worker. The table may not apply to you. You can earn more money and still be eligible.

#### What about things I own?

When you apply for Calfresh you can have up to \$2000 in savings or other assets.

#### Unless your household has:

- A child under 18 years old; then there is no limit on these assets.
- A person over 60 years old; then you can have up to \$3000.
- A person with a disability; then you can have up to \$3000.

You can own a house, have cars, and still qualify for Calfresh. These do not count toward the asset limit.

People who get Supplemental Security Income/ State Supplemental Payment (SSI/SSP) are not aligible for the Califosh Program in California, but other household members may be.

#### CalFresh Spanish-Language Brochure

#### Los beneficios de Calfresh pueden ayudarle a usted y a su familia.

- Si usted es la única persona en su hogar, usted puede solicitar Calfresh.
- Usted y su familia podrian calificar para recibir Califresh, aun si trabaja tiempo completo.
- Usted puede comprar alimentos en cualquier tienda de comestibles o mercado sobre ruedas que acepte tarietas EBT.
- Si usted califica, nunca tendrá que regresar los beneficios que reciba para Califresh.

#### ¿Cuánto recibiré cada mes en beneficios de Calfresh?

- La cantidad que reciba dependerá de sus ingresos, gastos y tamaño de su familia.
   La mayoría de los hogares que reciben
- beneficios de Calfresh obtienen aproximadamente \$200 cada mes.

#### ¿Cuándo empezaré a recibir beneficios de Calfresh?

- Si califica, obtendrá sus beneficios en menos de 30 días.
- Podrá obtener beneficios de Caitresh en tres días si sus ingresos son menos de \$150 en el mes en que los solicita y si tiene menos de \$100 en efectivo. Cuando solicite los beneficios, pregunte al trabajador de Caitresh si califica para el servicio de emergencia.

#### Reglas especiales

Los inmigrantes, los estudiantes, las personas de la lercera edad y aquellas personas que hayan cometido delitos gravés en el pasado, deben hablar con la oficina de Califesh para obtener más información. Las reglas pueden cembiar así que hable con su trabajador de Califesh

#### ¿Cuánto dinero puedo tener y aún obtener beneficios de Calfresh?

Usted puede:

- Ganar sueldo de un empleo.
  Recibir prestaciones de desempleo.
- Recibir asistencia/ayuda general.
- Recibir manutención de menores.
- · Ser parte de CalWORKs.
- · Recibir prestaciones de discapacidad.
- Tener una cuenta de ahorros.

Consuite la tabia de Ingreso mensual para ver si su Ingreso le permite calificar. Informe a su trabajador de Califesta i usted es discapacitado o es persona mayor (más de 60 años de edad). Es posible que esta tabia no corresponda a sus circunstancias. Usted puede ganar más dinero y todavía calificar.

#### ¿Qué pertenencias

#### personales puedo tener? Cuando solicite Califresh, usted puede tener

Cuando solicite Calfresh, usted puede tener hasta \$2000 en ahorros u otros blenes.

#### A menos que en su hogar haya:

- Un niño menor de 18 años de edad; entonces no hay límite para estos bienes.
- Una persona mayor de 60 años de edad; entonces puede tener hasta \$3000.
- Una persona discapacitada; entonces puede tener hasta \$3000.

Usted puede calificar para Calfresh aun teniendo casa propia o automóviles. Estos no cuentan hacia su limite de bienes.

Las personas que reciben Seguridad de Ingreso Suplementario de Estado (SSUSSF no pueden calificar para el Programa Califersh en California, pero otras personas que viven en su hogar podrian calificar.
