## CalFresh Legislation: An Overview of 2014 Legislative Proposals and Implementation Updates Main Galleria

## **Increasing CalFresh Participation through Outreach Partnerships West Meeting Room**

This workshop will highlight partnerships between CalFresh Outreach community-based organizations, counties, and other state agencies to increase California's CalFresh participation rate. Panelists will discuss innovative partnerships and strategies that have increased community-based organization CalFresh application approval rates, and a collaboration between a community based organization and the Women, Infants and Children (WIC) program that increases CalFresh participation. Attendees will also hear about new partnerships that CDSS has with the Department of Health Care Services and the state WIC program.
