CALFRESH OVERISSUANCE COST EFFECTIVE AND FAIR COLLECTION

Senate Bill 167 (Skinner)

CalFresh	Success	in	Re-Entry	/
----------	---------	----	----------	---

- □ Require CDSS to seek a waiver to allow for CalFresh Pre-Enrollment for people exiting prison or jail.
- Establish roles for County Human Services Agencies for pre-enrollment implementation.
- □ Require the state to seek a statewide MOU to cover all prisons in California (currently only 38% covered) which allow for people who are incarcerated to apply for a replacement SSI card or for SSI/SSP benefits.
- * Co-Sponsored by CWDA and Root and Rebound.

Senate Bill to Be Introduced (Wiener)

CalFresh Overisuance Bill will:
□Change "May" to "Shall" in existing law requiring state to establish a
CalFresh Overissuance Cost Effective Threshold.
□Require counties to report when a mass overissuance has been caused
by county action or inaction.
□Require the state to review to determine if the impacted recipients should
be protected by food stamp law established in the 2008 Farm bill which
deems the county or state responsible for the re-payment of the
overissuance in cases of negligence or large systems failure.

AB 214 (Weber & Skinner) CalFresh Student Rules

- AB 214 (Weber & Skinner) CalFresh Student Rules
- □Defines what half-time means for the purposes of establishing who the student rules apply to in Federal & State law.
- □Clarifies rules related to AB 1747 (Weber, 2016)
 - Requires RMP Application for Colleges in Participating Counties
 - Codifies practice of allowing public colleges & universities to participate in the State's CalFresh Outreach Program
- □Codifies decisions made in workgroup established by1930 (Skinner, 2014). AB 1930 establishes list of programs exempt & a verification process.

GET THE FACTS: FACTSHEETS ON ANTI-HUNGER LEGISLATION AVAILABLE ONLINE



According to California State University (CSU), one in five CSU students experience hunger and one in ten experience homelessness. In a survey recently conducted by the University of California Regents, it was found that one in ten University of California (UC) students do not have access to adequate food or nutrition. Furthermore, nationwide lab reports show that half of all community college students are struggling with housing and/or food insecurity.

Assembly Bill 1747, authored by Dr. Shirley Weber and signed by Governor Jerry Brown last month, addresses growing hunger among low-income college students in California. The bill provides the state with several new tools to draw down federal resources and aims to improve coordination between antihunger efforts on college campuses and anti-hunger efforts in the surrounding communities.



CalFresh Student Work Rule

Federal Law Restrictions & Recent State Law Provisions

When children born into the bottom fifth of the income distribution get a college degree, their chances of making it to the top fifth nearly quadruple, and their chances of making it out of the bottom increase by more than 50 percent. Opportunities for low-income high school graduates to escape poverty and climb into the middle class by attaining a college degree have narrowed over the past two decades. Several reports have documented the decline in low-income students attending college. Meanwhile, college students from low-income families who do attend college, are less able to finish and more likely to be strapped with unbearable debt if they do graduate.
