## **STATE WAIVER REQUEST**

- 7. Regulatory requirements: Section 6(o) of the Food and Nutrition Act of 2008, as amended, provides that no able-bodied adult without dependents (ABAWD) shall be eligible to participate in the Supplemental Nutrition Assistance Program (SNAP) as a member of any household if the individual received program benefits for more than 3 months during any 3-year period in which the individual was subject to but did not comply with the ABAWD work requirement. Section 6(o) also provides that, upon the request of the State agency, the Secretary may waive the applicability of the 3-month ABAWD time limit for any group of individuals in the State if the Secretary makes a determination that the area in which the individuals reside has an unemployment rate of over 10 percent, or does not have a sufficient number of jobs to provide employment for the individuals.
- **8. Description of alternative procedures:** The State of California is requesting to exempt ABAWDs in 52 counties from the SNAP time limits at 7 CFR 273.24.
- **9. Justification for request:** Under SNAP regulations at 7 CFR 273.24(f)(2), areas may support a claim of insufficient jobs by submitting evidence that an area has an average unemployment rate for a 24-month time period that exceeds the national average for the same 24-month period by 20 percent. 7 CFR 273.24(f)(6) provides that States may define areas to be waived.

The State of California seeks a waiver extension for a regional group of 52 contiguous counties based on the region having an average unemployment rate 20 percent above the national average for the 24-month period of January 2016 through December 2017. The national average unemployment rate for this 24-month period was 4.6 percent; 20 percent above this was 5.5 percent. The region's average unemployment rate for this period was also 5.5 percent. If approved, California will implement the ABAWD time limit as of September 1, 2019 in three new counties, for a total of 6 implementing counties. Those 6 counties include Alameda, Contra Costa, Marin, San Francisco, San Mateo, and Santa Clara.
