Re: Support for Investment in Early Care Nutrition

Dear Mr. Speaker, President Pro Tem Atkins, Chair Ting and Chair Mitchell:

For decades, California has supported access to nutrition for K-12th grade public school students by supplementing the federal reimbursement for school meals, but our youngest learners have continued to be ignored. As California works toward universal preschool and expanded access to child care, we must ensure the state's early care and education programs meet low-income children's basic needs, including access to healthy meals.

We therefore respectfully submit this request for \$16.6 million (\$14.6 million General Fund) in the 2019-20 State Budget in order to guarantee access to healthy meals for low-income children. These funds would supplement the federal reimbursement for serving meals to eligible, low-income children in preschool and child care at the same rate that school districts currently are reimbursed by the state for serving school meals.

We commend the Governor's priorities and goals to significantly increase access to preschool, and respectfully request the Committees and the Administration extend support to increase access to meals for children participating in California's early care and education programs. Providing food in child care is not optional for providers and families - state investments must support preschool and childcare providers in meeting that need. We know that children who start life with nutritious diets fare better, both physically and academically, and are more likely to thrive in school and later in life. But nearly one quarter of California's families can't afford to meet their basic needs. California's early care and education programs have a unique opportunity to support low-income families by guaranteeing that young children have access to nutritious meals during a critical stage of their development.

We look forward to working with the Budget Committees and the Administration to make healthy meals more justly and equitably accessible for our state's youngest learners.
