California voters, fiscal experts, the editorial board of the Sacramento Bee, the Assembly Education Committee, and a host of local and statewide anti-hunger, health, and education organizations stand behind AB 1240.

More than 750 individuals and 25 partner organizations signed on in support of AB 1240. On May 29, 2015 AB 1240 was held in the Assembly Appropriations Committee. That disappointing decision means the bill will not proceed further in 2015. CFPA is already hard at work planning a renewed state policy push. Increasing access to school breakfast is a win for students, schools, and the California
